



RELEASE, WAIVER OF CLAIM and ASSUMPTION OF RISK LEGAL GUARDIAN/PARENT OF UNDERAGE PARTICIPANT

I, the legal guardian of _____ PRINT PARTICIPANT'S NAME (hereafter "*the Participant*"), in consideration of permission, granted now or in the future to participate in **Thrill The World Calgary** (hereafter "*the Event*") on _____ PRINT EVENT DATE agree and acknowledge that:

1. *The Participant* has met all of the prerequisites required for participation in *the Event* and, to the best of my knowledge, *the Participant* is in good health and physical well-being; I do not have any knowledge that would or should otherwise prohibit or preclude *the Participant* from participating in *the Event*;

4. *The Event Organizers* may secure such medical advice and services as they, in their sole discretion, may deem necessary for *the Participant's* health and safety; *The Event Organizers* shall not be financially responsible for such advice and services;
